

The Corporation of the Town of Deep River

**By-law No. 14-2001**

A By-law to regulate the use of water for lawn sprinkling within the limits of the Town of Deep River.

The Council of the Corporation of the Town of Deep River enacts as follows:


- 1 In this by-law:
  - 1.1 "permitted hours" means the periods between 7:30 a.m. and 11:00 a.m. and between 6:00 p.m. and 9:00 p.m. on any day.
  - 1.2 "watering season" means the period from the first day of May to the thirtieth day of September inclusive in any year.
  - 1.3 "even calendar date" means a day in any month whose number is evenly divisible by two (eg. May 2<sup>nd</sup>, July 18<sup>th</sup>); and "odd calendar date" means a day which is not an even calendar date (eg. June 3<sup>rd</sup>, August 21<sup>st</sup> )
- 2 Council may by resolution alter the starting or ending date of the watering season in any year. Every year, before watering season begins, the Town Superintendent shall give public notice of the beginning of watering season and the requirements of this by-law.
- 3 The provisions of this By-law apply only to the watering of lawns, grass plots and gardens associated with private dwellings.
- 4
  - 4.1 During watering season, no person shall water any lawn, grass plot or garden on lands in the Town of Deep River where the municipal address number ends in 0, 2, 4, 6 or 8, except during permitted hours on even calendar dates.
  - 4.2 During watering season, no person shall water any lawn, grass plot or garden on lands in the Town of Deep River where the municipal address number ends in 1, 3, 5, 7 or 9, except during permitted hours on odd calendar dates.
- 5 In the event of a general fire alarm, no person shall water any lawn, grass plot or garden in any part of the Town of Deep River from the time the general alarm is given until the all clear signal is given.
- 6 The Council or its representative appointed by resolution may grant temporary exemptions from the provisions of this By-law for newly landscaped areas. Such exemptions shall be given in writing and shall be valid for a period not exceeding six weeks. A copy of every such written exemption shall be given to the Chief of Police forthwith after it is issued.

- 7      7.1    Every person who contravenes any of the provisions of Section 4 is guilty of an offence and on conviction is liable to a fine of not more than One Hundred Dollars (\$100.00) plus court costs.
- 7.2    Every person who contravenes any of the provisions of Section 5 is guilty of an offence and on conviction is liable to a fine of not more than Three Hundred Dollars (\$300.00) plus court costs.
- 8      By-law number 13-2000 is repealed.
- 9      This by-law comes into force at 12:01 a.m. on July 23, 2001.

READ A FIRST AND SECOND TIME THIS 4th DAY OF JULY, A.D. 2001.

READ A THIRD TIME AND FINALLY PASSED THIS 18th DAY OF JULY, A.D. 2001.


